

# NLH CASH GAME AB BLINDS 1/3

Every Friday from 19:00 at the Casino Innsbruck

## GENERAL:

NLH CASH GAME takes place weekly every Friday at Casino Innsbruck. Win an additional € 200, - every Friday from 19:00. The Cash Game Bonus applies to all NLH Cash Game tables from blinds 1/3. For each of the two winning card combinations, € 100, - is paid out in chips a maximum of once per day. Thus, the first player to win the hand with one of the following card combinations in the bonus period receives an additional € 100, - in chips.

- **TRIPS ON BOARD**

The winner of the hand with three of a kind in the board will receive € 100,- in chips.

- **RED CARPET**

The winner of the hand in which there are 5 red cards in the board receives € 100,- in chips.

A minimum of four players must be playing at the table for scoring to be in accordance with the rules. No showdown is necessary. The board only must be complete for RED CARPET. One hole card is sufficient. Each of the two winning card combinations is paid out a maximum of once per day. If no TRIPS ON BOARD or RED CARPET happens by 2:00, the action is over. In the event of a tie, the pay-out will be split (no colour scoring). Winners must be present at the time of pay-out.

## ELIGIBILITY:

All visitors to the above-mentioned Casinos Austria AG casino with valid, fully completed entry cards are eligible to participate. Admission to the casino from the age of 18 within the framework of the visiting and gaming regulations of Casinos Austria AG. Official photo ID required. By participating in the tournament (hereinafter also referred to as "Participants"), visitors accept the terms and conditions of the promotion as displayed in the casino. Employees of Casinos Austria AG and Cuisino GmbH, as well as any partners involved in the promotion, are not eligible to participate. The casino management makes the final decision regarding all aspects of the raffle, also regarding the eligibility, the validity of the entry cards and the course of the raffle. The legal process is excluded. Casinos Austria AG reserves the right to discontinue or terminate the promotion within the promotional period without stating reasons or to exclude visitors from participation, in particular in the event of violations of these terms and conditions of participation.

We would like to point out that legal or official regulations to prevent the spread of diseases (e.g. COVID-19 etc.) may come into force during the campaign period, which may completely prohibit the campaign from taking place during the campaign period, make it unreasonably difficult for casino visitors to participate or require adjustments or postponements. Should Casinos Austria AG be prevented from carrying out the promotion due to force majeure, these terms and conditions of participation shall be unilaterally adjusted. Force majeure shall be deemed to include, but not be limited to, the impossibility of implementing the promotion due to statutory or official orders or extraordinary natural events such as epidemics or pandemics (e.g. COVID-19).

Should any provision of the Conditions of Participation or part of a provision be invalid, this shall not affect the validity of the remaining provision and the Conditions of Participation. The implementation of the promotion is governed exclusively by Austrian law, excluding the UN Convention on Contracts for the International Sale of Goods and the conflict of law rules.

## LIABILITY

The liability of Casinos Austria AG and its bodies, employees and vicarious agents arising from or in connection with the promotion, irrespective of the legal grounds, is limited to cases of intent and gross negligence, except for personal injury. Casinos Austria AG accepts no liability for lost chances of winning.

## DATA PROTECTION NOTICE

Casinos Austria AG processes the following personal data only within the scope of all applicable national and European data protection regulations. For implementing and processing this promotion and ensuring compliance with the terms and conditions of participation, Casinos Austria AG will process the personal data of the participants resulting from the points "Mode of the draw" and "Eligibility" described above. This includes, in particular, the contact data required for the notification of the winner and, in individual cases, additional information such as information on the issuance of entry cards, on visits to the casino and participation in the Glücks Card program, insofar as this is indispensable for the implementation of the prize draw in accordance with these conditions of participation and as described above.
