

PL OMAHA CASH GAME

Every Monday from 19:00 at the Casino Innsbruck

GENERAL:

The PL Omaha Cash Game Days Only Blinds 2/2 take place weekly every Monday at Casino Innsbruck. Every Monday, every participant has an additional chance to win € 250 with the highest hand on all PL Omaha Cash Game tables with Blinds 2/2 in the following periods:

- 19:00 - 20:00: € 100,-
- 20:00 - 21:00: € 80,-
- 21:00 - 22:00: € 70,-

A minimum of four players must be playing at the table for scoring to be in accordance with the rules. No showdown is necessary. In addition, at least two hole cards must be used, and the board must be improved. In the event of a tie, the pay-out is split (no colour scoring). Winners must be present for the payout.

EARLY BIRD BONUS:

The Early Bird Bonus is valid on PL Omaha only Blinds 2/2 from 19:00 to 22:00.

The player with the highest hand (flush or higher) from 19:00 to 20:00 on all PL Omaha 2/2 cash game tables only Blinds 2/2 will receive € 100 in chips at 20:00.

The player with the highest hand (Flush or higher) from 20:00 to 21:00 on all PL Omaha 2/2 Cash Game tables only Blinds 2/2 will receive € 80 in chips at 21:00.

The player with the highest hand (flush or higher) from 21:00 to 22:00 on all PL Omaha cash game tables only Blinds 2/2 receives € 70 in chips at 22:00.

ELIGIBILITY:

All visitors to the above-mentioned Casinos Austria AG casino with valid, fully completed entry cards are eligible to participate. Admission to the casino from the age of 18 within the framework of the visiting and gaming regulations of Casinos Austria AG. Official photo ID required. Employees of Casinos Austria AG and Cuisino GmbH as well as any partners involved in the promotion are not eligible to participate. The casino management has the final decision regarding all aspects of the raffle, also regarding the eligibility, the validity of the entry cards and the course of the raffle. The legal process is excluded.

Casinos Austria AG reserves the right to suspend or terminate the promotion within the promotion period without stating reasons or to exclude visitors from participation, in particular in the event of violations of these conditions of participation.

We would like to point out that legal or official regulations to prevent the spread of diseases (e.g. COVID-19 etc.) may come into force during the promotion period, which may completely prohibit the promotion from taking place during the promotion period, make it unreasonably difficult for casino visitors to participate or adjust or postponements necessary. Should Casinos Austria AG be prevented from carrying out the promotion due to force majeure, these terms and conditions of participation shall be unilaterally adjusted. Force majeure shall include, but not be limited to, the impossibility of implementing the promotion due to legal or official orders or extraordinary natural events such as epidemics or pandemics (e.g. COVID-19).

Should a provision of the conditions of participation or part of a provision be invalid, this shall not affect the validity of the remaining provision and the conditions of participation. The implementation of the promotion shall be governed exclusively by Austrian law, excluding the UN Convention on Contracts for the International Sale of Goods and the conflict-of-law rules.

The liability of Casinos Austria AG and its bodies, employees and vicarious agents arising from or in connection with the promotion, irrespective of the legal grounds, is limited to cases of intent and gross negligence, except for personal injury. Casinos Austria AG accepts no liability for lost chances of winning.

DATA PROTECTION NOTICE
