# **POKER CASH GAME** – Bad Beat Jackpot

CASINO: Casino Salzburg

PROMOTION DAYS: Every day on which Poker Cash Game

takes place.

PLAYOUT PERIOD: 5:30 PM - 4:00 AM

PRIZE: at least 150 euros in chips

### **MODE**

The Bad Beat Jackpot is played in Texas Hold'em No Limit (from blinds 1/3) and Pot Limit Omaha (from blinds 2/2). The player who loses with the highest bad beat of the day will receive at least € 150 in chips at midnight. The highest bad beat after midnight counts for the following day. If there is no bad beat on a Poker Cash Game day, the current jackpot is increased by € 150. A bad beat is when you lose the showdown with a full house or higher.

- The Bad Beat Jackpot applies to Texas Hold'em No Limit and Omaha Pot Limit.
- The highest hand starting with a full house is counted.
- The pot must be assessed.
- There must be at least five players at the table.
- In Texas Hold'em No Limit, at least one hole card must be used and the board must be improved.
- The floorman must confirm the bad beat.
- A showdown is required.
- In case of a tie, the payout is split (no color scoring).
- The winner must be present for the payout of the bad beat jackpot at 24:00. If the
  winner is not present, the current jackpot will be increased by € 150 on the next Poker
  Cash Game day.

- With "Deal it twice", only the top board counts.

#### **ELIGIBILITY TO PARTICIPATE**

All visitors to the above-mentioned Casinos Austria AG casinos are eligible to participate. Admission to the casino is restricted to persons aged 18 and over in accordance with the respective visiting and gaming regulations of Casinos Austria AG. Valid official photo ID is required.

Employees of Casinos Austria AG and Cuisino GmbH, as well as any partners involved in the promotion, are not eligible to participate. The casino management makes the final decision regarding all aspects of the prize draw, in particular with regard to eligibility to participate, the validity of the participation cards and the course of the prize draw.
