

POKER EM – BADBEAT JACKPOT

** The prizes are non-transferable and cannot be redeemed in cash.

MODE & PARTICIPATION

The BadBeat jackpot is valid from blinds 1/3 in Texas Hold'em No Limit and from blinds 2/2 in Pot Limit Omaha during the promotion period mentioned above. The player who loses with a full house AAA XX, where both cards must be used and one of them must be an ace, wins 500 euros in game chips at 05:00 CET.

- The BadBeat Jackpot is valid during the promotional period and will be paid out a maximum of twice per game day. Once for Texas Hold'em and once for Pot Limit Omaha.
- The BadBeat jackpot is valid from blinds 1/3 in Texas Hold'em No Limit and from blinds 2/2 in Pot Limit Omaha.
- A "bad beat" is when you lose AAA XXX to a full house, where both cards must be used and one of them must be an ace.
- Excludes BombPots, Flips, Double Board and other games that deviate from the standard procedure.
- At least four players must have actively participated in the hand. Der Showdown ist notwendig und muss vom Floorman bestätigt werden.
- In Texas Hold'em, both hole cards must be used.
- The board needs to be improved.
- In the event of multiple winners or a tie, the payout will be split (no suit scoring).
- If no player reaches this value on the respective promotional day, the prize amount will be added to the next day.
- The promotion can be discontinued at any time without giving reasons.
- On Saturday, July 26, 2025, the promotion ends and on that day the entire sum will be shared among the highest 3-5 BadBeats (depending on the amount of the prize money)
 - Winning amount 500 euros to 2,500 euros – the highest three bad beats
 - Winning amount 3,000 euros to 12,000 euros – the highest five bad beats

ELIGIBILITY

All visitors to the above-mentioned casinos of Casinos Austria AG are eligible to participate. Admission to the casino from the age of 18 within the framework of the visiting and gaming regulations of Casinos Austria AG. Official photo ID required.

Employees of Casinos Austria AG and Cuisino GmbH, as well as any partners involved in the campaign, are not eligible to participate. The Casino Management will make the final decision on all aspects of the game, including but not limited to eligibility, the validity of the tickets and the course of the game. Legal recourse is excluded.

Casinos Austria AG reserves the right to discontinue or terminate the promotion within the campaign period without giving reasons or to exclude visitors from participation, in particular in the event of violations of these terms and conditions.

We would like to point out that legal or official provisions to prevent the spread of diseases (e.g. COVID-19, etc.) may come into force during the campaign period, which may completely prohibit the promotion from taking place during the campaign period, make it unreasonably difficult for casino visitors or make adjustments or postponements necessary. If Casinos Austria AG is prevented from carrying out the campaign due to force majeure, these terms and conditions of participation will be unilaterally amended. In particular, but not exclusively, the impossibility of implementing the promotion due to legal or official orders or extraordinary natural events such as epidemics or pandemics (e.g. COVID-19) shall be considered a case of force majeure.

If any provision of the Terms and Conditions of Participation or any part of a provision is invalid, this shall not affect the validity of the remaining provision and the Terms and Conditions of Participation. Austrian law applies exclusively to the implementation of the campaign, to the exclusion of the UN Convention on Contracts for the International Sale of Goods and the conflict of law provisions.

The liability of Casinos Austria AG and its organs, employees and vicarious agents arising from or in connection with the action, regardless of the legal grounds, is limited to cases of intent and gross negligence, with the exception of personal injury. Casinos Austria AG does not assume any liability for lost chances of winning.

PRIVACY POLICY

Casinos Austria AG processes the following personal data only within the framework of all applicable national and European data protection regulations.

For the purpose of carrying out and processing this campaign and ensuring compliance with the terms and conditions of participation, Casinos Austria AG will process the personal data of the participants resulting from the above-described items "Game mode" and "Eligibility to participate". In particular, this includes the contact details required to notify the winner and, in individual cases, additional information such as information on the issuance of participation cards, visits to the casino and participation in the Glücks Card programme, insofar as this is indispensable for the implementation of the competition in accordance with these terms and conditions of participation and as described above. The processing of personal data is carried out on the basis of Article 6 (1) (b) of the GDPR (performance of a contract).
